

WHEREAS:

The Yankton Sioux Tribe is an unincorporated Tribe of Indians operating

Under an Amended Constitution and By-Laws approved on April 24, 1963

June 16, 1975, and March 23, 1990; and

WHEREAS:

The Yankton Sioux Tribes Business and Claims Committee is the elected

Body constituted for the purpose of conducting the business of and

Serving the best interest of the Yankton Sioux Tribe and the membership; and

WHEREAS:

The Yankton Sioux Tribe received funds from the Department of Treasury

Under the CARES ACT (\$10.2) million; and

WHEREAS:

The Yankton Sioux Tribes Business and Claims Committee Treasurer is Working on a plan for the CARES ACT Funds that incorporates many Suggestion that we have received with the goal of helping all tribal citizens

In this war against the COVID 19 Virus; and

WHEREAS:

The Yankton Sioux Tribes Business and Claims Committee Treasurer presented

A proposal to invest the CARES ACT Funds in Certificates of Deposit (CD's)

With Commercial State Bank of Wagner, SD; and

WHEREAS:

The Yankton Sioux Tribes Business and Claims Committee Treasurer met with

The President of the Commercial State Bank, Wagner, SD, to discuss the

Proposed plan of depositing the CARES ACT Funds in Certificates of Deposits;

(CD's) that will draw interest for (60) day and (90) day investments; and

WHEREAS:

The Yankton Sioux Tribes Business and Claims Committee approved the

Treasurer's plan to deposit the CARES ACT Funds in Certificates of Deposits

(CD's) with Commercial State Bank of Wagner, SD; and

WHEREAS:

The Department of Treasury has authorized the funds to be deposited in Interest bearing accounts provided that interest earned or other proceeds Of these investments only to cover expenditures incurred in accordance With section 601 (d) of the Social Security Act and the Guidance on eligible

Expenses

NOW THEREFORE BE IT RESOLVED, that the CARES ACT Funds will be entered into CD's as

Follows:

(\$5 million) @ (90) days at .20% = \$2,500

 $(\$_3 \text{ million}) @ (60) \text{ days at .25}\% = \$_750$

BE IT FURTHER RESOLVED, That the Chairman, Robert Flying Hawk and the Secretary, Glenford Sam Sully, of the Yankton Sioux Tribe Business and Claims Committee are hereby authorized to execute documents on behalf of the Yankton Sioux Tribe.

THIS IS TO CERTIFY AND AFFIRM, the above and foregoing resolution was duly authorized and Passed by the Yankton Sioux Tribe's Business and Claims Committee on the <u>15</u> day of June 2020 At a Regular meeting held at the Yankton Sioux Tribal Headquarters, Wagner, South Dakota on The Yankton Sioux Reservation, by a vote of <u>6</u> in favor, <u>7</u> opposed, <u>7</u> not voting, <u>2</u> absent <u>1</u> abstaining. MOTION CARRIED.
