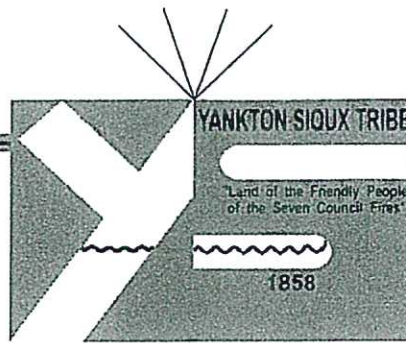

RESOLUTION NO. 2020-96**

Authorization to Purchase Commercial Property for COVID-19 related use for the Yankton Sioux Tribe.

A duly called meeting of the Yankton Sioux Tribe was held on August 4, 2020, and the following resolution was adopted:

WHEREAS: The Yankton Sioux Tribe is an unincorporated Tribe of Indians that is not subject to the Indian Reorganization Act of 1934; and

WHEREAS: The Yankton Sioux Tribe is an unincorporated Tribe of Indians operating under an amended Constitution and By Laws approved on April 24, 1963; June 16, 1975 and March 23, 1990; and

WHEREAS: The Yankton Sioux Tribe's Business and Claims Committee is the elected body constituted for the purpose of conducting the business of and serving the best interest of the Yankton Sioux Tribe and its membership; and

WHEREAS: The Yankton Sioux Tribe's Business and Claims Committee has contributed throughout the years to improving the standard quality of life on the Yankton Sioux Reservation; and

WHEREAS, The Yankton Sioux Tribe is in support of the State-Local-Tribal Coronavirus Aid Relief, and Economic Security (CARES) Act; and

WHEREAS, The Yankton Sioux Tribe agrees that the Distribution of Coronavirus Relief funds should be distributed to each Tribal government its entire allocation of Coronavirus Relief funds on April 24, 2020, with the statutory mandate for payment withing 30 days of passage of the CARES Act; and

WHEREAS, The Yankton Sioux Tribe in accordance to the Amended By-Laws of the Yankton Sioux Tribe Article IV- Management Section 1. approves the purchase of the commercial property of the commercial property located at 219 S. Main Avenue, in Wagner, South Dakota located in Charles Mix County. Legal description Lot 10, Block 3, in the original town, now city of Wagner, South Dakota also known as Stacy's Expressions.

WHEREAS, The Yankton Sioux Tribe approved brokerage services from Keller Williams Siouland to represent YST in securing the commercial property. A \$2,500 earnest fee payable to Juffer Real Estate.

WHEREAS, The Yankton Sioux Tribe's Business and Claims Committed approved the purchase agreement between Juffer Real Estate and the Yankton Sioux Tribe in the amount of \$45,000.

NOW, THEREFORE, BE IT RESOLVED, that Yankton Sioux Tribe hereby will utilize this commercial property to support COVID19 related activities, storage space and establish a task force department in accordance to the CARES Act; and

BE IT FURTHER RESOLVED, That the Yankton Sioux Tribe's Business and Claims Committee authorizes its Chairman, or in the absence, the Vice-Chairman, to execute any and all documents as may be necessary to further the intent of this resolution.


CERTIFICATION
